- Upper Michigan Energy Resources Corporation requests Michigan Public Service Commission's approval for reconciliation of its power supply cost recovery plan (Case No. U-20533) for the 12-month period ended December 31, 2020.

The Michigan Public Service Commission (Commission) will hold a pre-hearing to consider Upper Michigan Energy Resources Corporation (UMERC)'s March 18, 2021 application requesting the Commission to: 1) approve the reconciliation of UMEREC's 12-month power supply costs and revenues as presented by UMEREC; 2) determine that the power supply costs incurred by UMEREC during 2020, as included in this reconciliation, were reasonably and prudently incurred; 3) determine that UMEREC's net cumulative under-recovery of \$157,173, as of December 31, 2020, for its WEPCO Rate Zone, should be rolled into the beginning balance of its 2021 PSCR reconciliation for its WEPCO Rate Zone; 4) determine that UMEREC's net cumulative over-recovery of \$92,079, as of December 31, 2020, for its WPSC Rate Zone, should be rolled into the beginning balance of its 2021 PSCR reconciliation for its WPSC Rate Zone; and 5) grant UMEREC other and additional relief.

All documents filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscedockets. Requirements and instructions for filing can be found in the User Manual on the E-Dockets help page. Documents may also be submitted, in Word or PDF format, as an attachment to an email sent to: mpscedockets@michigan.gov. Any person wishing to intervene and become a party to the case shall electronically file a petition to intervene with this Commission by May 4, 2021. Wellman, One Michigan Ave., Ste. 900, Lansing, MI 48933.

The prehearing is scheduled to be held remotely by video conference or teleconference. Persons filing a petition to intervene will be advised of the process to participate in the hearing.

Any person wishing to participate without intervention under Mich Admin Code, R 792.10413 (Rule 413), or file a public comment, may do so by filing a written statement in this docket.
